# **Campsite Report**

The campsite has had a difficult year with the pandemic meaning no camping has been possible since March 2020. However since August groups have been using the site as an essential meeting space, Drummers has been ideal in allowing groups to meet outside in line with Government guidelines.

This year has been poor financially with a large summer cancelation last summer, plus the current pandemic. The retail hospitality and leisure grant has compensated as Drummers was awarded a £10,000 grant allowing the site maintenance to continue.

The Drummers lodge team have worked hard to put together a site development plan with funding actively being sought to allow for the improvements to be made over the next 3-5years.

This year's improvements have been:

- All the toilets have been decorated thanks to John Sargeant and Alan Tregaskes.
- All ground maintenance has been carried out as usual thanks to Mark Tippett for his help.
- We are now carrying out improvements to the Marquee area and the area to the left of the entrance gate with help from Ross Sargeant, Shaun Wakeham and Ben Powlesland.
- We are also making extra provision for shipping containers at the top of the site as the district
  events team need an extra container, also the guides container will be moved to that area allowing
  for increased parking space
- The driveway has been widened to improve parking and site access.


