The overall youth membership in January 2022 was marginally up on the previous year by 4 members. Adult membership is down by 26.

At the time of recording there were 4 less Beaver colonies, 3 less cub packs, 3 less Scouts Troop and 1 less Explorer unit than in 2021. It should be noted however that 1st Gorran and Mevagissey have restarted all 3 sections from their new base at Heligan.

Of the sections that were open at the time of the census, those with 11 or less members, has decreased. There were 19 in 2021 and now 15 in 2022.

District Chair's Report

It has been a short year for the District Executive Committee, being formed in September 2021 after a later than usual AGM. Firstly, I would like to recognise the hard work done by District Executive Committee, as it is often behind the scenes and many leaders, parents & young people won't see the impact the committee has. Thank you to the District Scout Council, you as leaders and members, for voting in a fantastic team. From day one your District Executive Committee showed their commitment and enthusiasm for building on the amazing works done by previous committees.

At our first meeting in October 2021, we formed the four subcommittees, who have also worked tirelessly to provide the Executive Committee with recommendations and advice relating to their specialism. The Finance, Appointments Advisory, Safety and Drummers Lodge committees have been chaired by four very experienced Scouters and they continue to steer some brilliant projects.

Supporting our District Treasurer the Finance Subcommittee have helped to consolidate our bank accounts. HSBC recently introduced charges on their charity accounts, resulting in us having to potentially pay over £300 per year. The committee has helped to reduce that fee to just under £100 per year, with further work being done to bring that to as close to £0 as possible!

The Drummers Lodge Subcommittee have helped produce the start of a development plan for the site, including some very exciting new projects which we hope to see in the coming years. The committee has been successful in receiving grant funding for a new washing-up area, so watch this space for that to start coming together.

Working alongside the Drummers Lodge Subcommittee the Safety Subcommittee has assisted with documenting the maintenance schedule for the campsite. This work has ensured we, as a District, are up to date with mandatory inspections and therefore keeping our young people, adults, and visitors safe. The committee have also reached out to all groups offering their support in auditing buildings and meeting places.

You may already be aware, but there is a project ongoing in Scout HQ to revamp the volunteer experience, this includes the experience adults have when they become leaders or take on role, whether they are new to Scouting or already have another role. The Appointments Advisory Committee have been keeping up to date with the latest proposals and changes, updating the District Executive and recommending procedural amendments. Whilst continuing to run appointment panels to welcome new leaders and supporters and continuing to advise on role reviews. We have also signed an agreement with Falmouth District, to support them with their Appointments process.

In addition to all this as a District Executive committee we have introduced Microsoft Office365 to the District, providing branded email accounts, better data protection and options to use other online services. Fingers crossed, all the forms you do online for this AGM have been hosted on Office365. We have agreed to create an assistance fund for capitation, inline with national support applications.

AGM Papers

We have started up a regular meeting with Group Chairs to support groups better. We have completed the merger of the Drummers Lodge charity and newly formed Mid Cornwall Scouts charity, ensuring our governance and financial liabilities are best protected.

Finally, I would like to say thank you again to everyone on the District Executive Committee and Subcommittees. I have thoroughly enjoyed getting stuck in and I hope you can see that we have worked hard to continue making Mid Cornwall the best. As I write this, I hope that I will be nominated again, as looking at future developments starting to be discussed at HQ, I am excited to possibly be a part of that.

I would like to thank all the appointments committee for all the hard work they put in to help and assist the district and also the members of the other committees and the leaders that turn up week after week wind, rain or shine to help support what is one of the best youth organisations to be involved with.

Financial accounts for the year ending 31st March 2022 audited by Peter Williams.

We have consolidated a number of accounts this year to reduce the bank charges which we are now having to pay due to HSBC changes in their terms and conditions of small business accounts.

Notes on the District accounts.

There was £150 added to the Brownsea fund which was left over money from pre covid events still held in the events account. As no Brownsea trip took place again this year, the money was moved back to the district account.

The events account is still being used to administer the group funds for The Clays – they are in the process of opening their own account but not completed by the year end. The cash in hand of £1 is The Clays.

Notes on Drummers Lodge accounts

Grant receipts was from the Government COVID schemes for small businesses, plus £950 from Southwest Water towards a washing up station.

Notes on Scout Shop account

Sales are much higher then previous year with the return to Scouting. £2000 from the profits of Scout Shop has been transferred back to the district to be used as part of the hardship fund.
